The firm shall supply and install the CCTV at different prominent places of Mondei and Pallishree Mela-2023 ground.

- I EMD- The Bidders are required to deposit **Rs 2,000/- (Two thousand)** only as an EMD in shape of Demand Draft in favour of M/S Pallishree Mela, Nabarangpur drawn on any bank payable at Nabarangpur. Bidders may not required to deposit EMD who comes under exempted category.
- II Cost of Tender Papers- **A non-refundable amount of Rs.1180 ( One thousand One hundred eighty) only** is to be deposited along with the Tender in shape of Demand Draft in favor of M/S Pallishree Mela, Nabarangpur drawn on any nationalized bank payable at Nabarangpur towards the cost of tender paper. The authority will not be responsible if any portion of downloaded Tender paper differ from the approved tender paper available in the office of the Deputy CEO ,ORMAS, Nabarangpur.
- III **The sealed quotations shall be accepted as per the prescribed Performa only, otherwise the quotation shall be rejected automatically.**

- VII The Firm will fix the cameras at prominent places also draw the cable wiring to all the prominent areas for CCTV coverage .

The Firm shall engage at-least two dedicated persons for duty round the clock at Control room for emergency work at stalls and ground for ascending and descending works. The persons engaged will take daily attendance from the Control room and the attendance will be attach along with bills while submitting the bills for payment.


- VIII **The quoted price in the bid should not be exceeding the current price in the open market.**

- XII Payment will be made within a period of one month after successful completion of the work as per the specification, otherwise proportion amount will be deducted at the time of the sanction of the Bill
