5. Bid shall only be received through Registered /Speed post only on or before **16:00 Hours of 2<sup>nd</sup> January 2024**. The authority will not be responsible for any postal delay. The bids received during the above said period will only be considered.
6. The bidder must quote their price in INR only as the payment will be made in Indian Currency only.
7. Tax deduction at source (TDS) shall be done as per the provision of IT Act/Rules.
8. The bid paper cost and EMD amount should be submitted separately in two separate Demand Draft only.
9. No bids shall be considered valid if not accompanied with bid paper cost (Non-refundable) & EMD **only in the shape of Demand Draft** in favour of **BDO Raighar** payable at SBI, Raighar.
10. Any bid received without any or all of the documents mentioned in the Non- responsive/ rejection criteria of the DTCN shall be considered non-responsive and will be liable for rejection.
11. For a particulars work a bidder can submit only one tender paper. Submission of more than one tender paper by a bidder for a particular tender, will be liable for rejection of all such tender paper.
