02. The Bid documents will be available in the website: www.nabarangpur.nic.in from 10.00 Hours of 11th January 2024 to 16.00 Hours of 19th January 2024 for downloading.
03. No tender paper will be sold by this Office. Interested bidders will download the bid documents from the website www.nabarangpur.nic.in.
04. The bids shall be received only at Office of the BDO Kosagumuda through Regd. Post/Speed Post only.
05. Bid shall be received through Registered/ Speed post only on or before 17.00 Hours of 19th January 2024. The authority will not be responsible for any postal delay. The bids received during the said period will only be considered.
06. The bidder must quote their price in INR only as the payment will be made in Indian Currency only. The rate quoted should be excluding GST as applicable.
07. Tax deduction at source (TDS) shall be done as per the provision of IT Act/ Rules.
08. The tender cost (Cost of Bid documents and EMD/ Security amount should be submitted separately in two separate demand draft only.
09. No bids shall be considered valid if not accompanied with tender cost (Non-refundable) & EMD only in shape of demand draft in favour of BDO, Kosagumuda payable at SBI, Kosagumuda.
10. Any Bid received without any or all of the documents mentioned in the Non-responsive/ Rejection criteria of the DTCN shall be considered non-responsive and will be liable for rejection.
11. For a particular work a bidder can submit only one tender paper. Submission of more than one tender paper by a bidder for a particular tender, will be liable for rejection of all such tender paper.


12. The bids received within the stipulated time through registered /speed post only shall be opened at 15.00 hours on 20th January 2024 in the conference hall of Panchayat Samiti, Kosagumuda in presence of the bidders / their authorised representatives, who wish to attend.
13. The authority reserves the right to reject any or all bids without assigning any reason thereof.
14. The bidders willing to avail concessional payment of EMD as per Govt. of Odisha in Works Department OM No.503 dated.17.01.2022 shall submit all the required documents alongwith the Bids.
15. Amount quoted will be considered up to an accuracy of two decimal points in all cases.
16. In case the amount quoted in the bids by two or more bidders are equal, transparent, lottery system will be used to decide the successful bidders.
17. Subsequent corrigendum/ Addendum if required shall only be available in the website indicated above.
