Sealed quotation on plain paper are invited from the bonafide suppliers / firms having valid GST / IT Registration for installation of CCTV at nomination, dispersal / receiving and counting centers on hire basis to be used during forthcoming Simultaneous General Election, 2024 so as to reach the undersigned on or before **26.02.2024 by 3.00 PM by Speed post / Registered Post** . The quotations will be opened by the members of District Level Purchase Committee on the **27.02.2024 at 3.00 PM** in the office chamber of A.D.M.(General), Nabarangpur in presence of the members of District Level Purchase Committee and the Quotationers or their authorized agents . Quotations received after the stipulated time shall not be accepted.

Term & Conditions

01. The Quotationer must have experience for doing such installation of CCTV cameras .
02. The Quotationer has to install approximately 40 nos of 360* CCTV cameras in 7 centers namely 5 nominations centers, 1 dispersal / receiving centre and 1 counting centre. The hiring of CCTV camera may be subject to increase / decrease as per requirement.
03. The Quotationer should quote hiring charge of 1no of 360* camera , 1 DVR , 1 display unit including cable and all taxes. The Quotationer also quote price of 40 nos of 360* CCTV Cameras , 40 nos of DVRs 40 nos of display units and cables separately.
04. The required quantity of aforesaid equipment need to supplied by the supplier and install 3 days from commencement of poll without fail.

05. The Quotationer has to submit the Xerox copy of the valid certificate of clearance of IT for the year 2022-23 & updated GST clearance, without which the quotation will not be taken into consideration.
06. The selected Vendor have to deposit security money amounting to Rs 25,000.00 (Rupeestwenty thousand) only in shape of Bank Draft drawn in favour of District Election Officer & Collector, Nabarangpur.
07. In case of failure to supply the required no of articles and quantity in full as per specification within stipulate period the security money will be forfeited and criminal liability as per Election rule will be fixed.
