

- 6 If a vehicle for which permission is given to a particular candidate is found being used for another candidate, then the permission shall be withdrawn and such vehicle seized by/ under the authority of District Election Officer.
- 7 Permission given to the candidates being used by another vehicle will be liable for seizure & expenditure for the entire period will be added.
- 8 Only one flag of size 3 X 2 ft is allowed for 4 wheelers as per instruction Sl.no.88 of MCC
- 9 Penal action shall be taken under provisions of the Representation of the People Act, 1951 and Chapter IX A of the Indian Penal Code, in addition to the Motor Vehicles Act against the persons violating the above direction. Any vehicle being used in violation of these directions shall be confiscated.
- 10 Carrying of illegal arms, illicit liquor and anti -social elements is strictly prohibited.
- 11 If the vehicle permitted to any independent candidate or any other candidate is found carrying campaign material of another candidate or being used for campaign for any other candidate
