- 1 The Model Code of Conduct for General Election 2024 shall not be violated.
- 2 The original copy (not the photo copy) of permit, in such dimension that it can easily be seen from a distance, should be displayed on the wind screen of the vehicle.
- 3 The candidates are required to display the permits issued by the authorities in the wind screen of the vehicle.
- 4 In four-wheel vehicles not more than five person including the driver will be allowed. Vehicles shall, under no circumstances, be allowed to move in convoys of more than ten vehicles, excluding the security vehicles. The convoys, including those carrying a minister of Central or State Government., exceeding ten vehicles shall be broken up and a gap of 100 metres would be maintained for the permission days.
- 6 If a vehicle for which permission is given to a particular candidate is found being used for another candidate, then the permission shall be withdrawn and such vehicle seized by/ under the authority of District Election Officer.  
Permission given to the candidates being used by another vehicle will be liable for seizure & expenditure for the entire period will be added.
- 8 Only one flag of size 3 X 2 ft is allowed for 4 wheelers as per instruction Sl.no.88 of MCC
- 9 Penal action shall be taken under provisions of the Representation of the People Act, 1951 and Chapter IX A of the Indian Penal Code, in addition to the Motor Vehicles Act against the persons violating the above direction. Any vehicle being used in violation of these directions shall be confiscated.
- 10 Carrying of illegal arms, illicit liquor and anti-social elements is strictly prohibited.
