The District Education Officer, Nabarangpur invites bids from the reputed & credible firms/ Manufacturers for supply of Single Bed Cot, Wooden Reading Table, News Paper Stand / Magazine Stand & Steel Book Self / Book Case for 11 numbers of KGBV-type III Hostels of Nabarangpur District. The detailed terms & conditions of the above bid are as under;

SCOPE OF WORK AND GENERAL INSTRUCTIONS FOR BIDDERS

1. Eligibility Criteria:

The firms / manufacturers must have:

- (a) Valid PAN and with up-to-date clearance certificate of ITR filing copy.
- (b) Valid GST Registration Certificate and upto date GST filing copy of relevant preceding month / quarter

2. Application Procedure:

- (a) The Bid has been invited under two bid system i.e. **Technical Bid and Financial Bid**. The interested bidders are advised to submit two separate sealed envelopes super scribed “Technical Bid for supply of Single Bed Cot, Wooden Reading Table, News Paper Stand / Magazine Stand & Steel Book Self / Book Case for 11 numbers of KGBV-type III Hostels” & “Financial Bid for supply of Single Bed Cot, Wooden Reading Table, News Paper Stand / Magazine Stand & Steel Book Self / Book Case for 11 numbers of KGBV-type III Hostels”. Both sealed envelopes should be kept in another sealed envelope super scribed “Tender for supply of Single Bed Cot, Wooden Reading Table, News Paper Stand / Magazine Stand & Steel Book Self / Book Case for 11 numbers of KGBV-type III Hostels”.

(b) Technical Bid & Financial Bid.

The Bidder has to fill up the Technical bid Form (**Tech-1, Tech-2, Tech-3, Tech-4**) & submit it with a separate envelope with all self-attested documents / papers. Similarly, the Financial Bid form has to be filled up as per prescribed form (**Fin-1 & Fin-2**) and to be submitted in separate sealed envelope. The bidder is to quote per aforesaid furniture rate in the prescribed format (FIN-2). The per Furniture rate shall include all other charges/levies/duties including GST, transportation cost & delivery of the items at school point. The tender should be addressed to O/o the District Project Coordinator, Samagra Shiksha, Nabarangpur, Pin 764059.

- (c) The Bid document shall be available in website www.nabarangpur.odisha.gov.in and www.osepa.odisha.gov.in the cost of the tender paper of Rs.1,000/- is to be enclosed in shape of

crossed Demand Draft / Banker's Cheque in favour of "**DISTRICT PROJECT COORDINATOR, SAMAGRA SHIKSHA, NABARANGPUR**", payable at **NABARANGPUR** along with the **Technical BID**.

- (d) Earnest Money Deposit (EMD): The bidder is to submit EMD amounting to Rs.42,000/- (Forty-two Thousand) only. The EMD (refundable - without interest), may be submitted in shape of Demand Draft / Banker's cheque/ Bank Guarantee (Format A) from any Nationalized or scheduled bank drawn in favour of **DISTRICT PROJECT COORDINATOR, SAMAGRA SHIKSHA, NABARANGPUR**, payable at **NABARANGPUR**, failing which the tender shall be rejected summarily. In case of Bank Guarantee, it should be valid up to at least 90 days beyond the date of opening of Financial Bid. The instrument in original should be necessarily accompanied with the Technical Bid. The EMD of the un-successful bidders shall be refunded within 30 days after award of contract. The EMD shall be forfeited in the event of withdrawal of the tender once submitted OR in case of a successful bidder who (i) fails to execute the agreement within specified period & (ii) not submitted performance security and/or express its inability to supply the finished material within the stipulated period. The EMD of successful bidder shall be refunded after receipt of Performance security.

- (e) The interested Bidders are to enclose self-attested photocopies of the following valid documents /papers **in the Technical Bid envelope**. The proposal submitted without the following documents/papers shall not be considered.

- (e) Updated GST return file upto January 2025 for monthly and upto December 2024 Quarterly Tax Payers.
- (f) DD/Bankers Cheque amounting to Rs. 1,000/- as bid processing fee
- (g) EMD of Rs.42,000/- in shape of Demand Draft / Bankers Cheque / Bank Guarantee.
- (h) Duly filled in, signed & sealed Tech-1, Tech-2, Tech-3 & Tech-4 formats.

- (i) Sample of items for which quoted. Brochures / Photographs with Specification must be provided for the quoted items.

3. The Bidder who meets the requirements specified in the Technical Bid will only be considered for participating in the Financial Bid. Financial Bid of the technically disqualified bidders will not be considered & opened.

4. Submission & opening of Tender:

- (a) The interested Bidders may submit the tender document complete in all respects along with EMD, bid processing fee and other requisite documents on or before Dt. 26.03.25 Up to 5.30 PM (in all working days) addressed to O/o the District Project Coordinator, Samagra Shiksha, Nabarangpur, Pin 764059 only by **registered Post / Speed Post**. The Authority is not responsible for any postal delay. No other mode of submission of bid shall be entertained.
- (b) **Late Bidders:** Any bid received by the authority after the prescribed time and dateline for submission of bids will not be considered and opened. Thus the same is deemed to be rejected.
- (c) The Technical bids shall be opened on the scheduled date and time at 10.30 AM on Dt. 27.03.25 in the O/o the Collector, Nabarangpur, in the presence of the authorized representatives of the bidders, if any, who wish to be present on the spot at that time.
- (d) The Financial Bid of only those bidders will be opened whose Technical bids are found in order. The date, time & place of opening of Financial BID will be communicated after evaluation of Technical BID.

The requirement of each item may increase or decrease.

6. Evaluation of BID:

- (a) The Purchase and Financial Committee of the District Education Office will evaluate the Technical & Financial BID. The Bidder who meets the requirements specified in the Technical Bid will only be considered for participating in the Financial Bid. Financial Bid of the technically disqualified bidders will not be opened.
- (b) The technically qualified bidder quoting lowest price in the Financial bid shall be considered for award of contract.

7. Acceptance or Rejection of the Bids:

- (a) The TIA reserves the right to accept / reject any / all bids / cancel the entire selection process at any stage without assigning any reason thereof. No claim, whatsoever, shall be admissible for the alleged loss/damage suffered by the bidder/s on account of such rejections.
- (b) Any bid with incomplete information is liable for rejection.

8. Award of Contract:

The contract will be awarded to the Bidder/s substantially responsive to the Bid document & offered lowest evaluated cost. The soft copy of posters will be provided to the successful bidder.

9. Signing of Contract:

- (a) The successful bidder/s whose bid has been accepted will sign an agreement with the TIA within 03 (three) days of issue of the work order.
- (b) Failure by the tenderer to comply with the requirement of above mentioned clause, the offer shall be rejected and the tenderer shall have no claim further.

10. Performance Security Deposit:

The selected bidder shall have to submit Performance Security Deposit of 05% of contract value in shape of Demand Draft / Bankers cheque drawn on any Nationalized / Scheduled Bank.

11. Post Delivery Inspection (PDI):

The TIA shall do the PDI of the quality of the items.

12. Requirement & Delivery Schedule:

The selected firm shall supply for supply of Single Bed Cot, Wooden Reading Table, News Paper Stand / Magazine Stand & Steel Book Self / Book Case for 11 numbers of KGBV-type III Hostels of Nabarangpur District wise within 30 days from the date of issue of the work order. The above requirement may increase or decrease as per need. The total cost will be decided on the basis of actual nos. of Items.

13. Payment terms:

- (i) **On completion of delivery at KGBV point** :100% cost of the supplied quantity shall be paid within 30 days after receipt of the required reports / Papers/ documents as under
- Challans towards satisfactory completion of supply of quantity to concerned KGBV – Type III hostel point as per supply order.
 - Receipt of “receive & stock entry certificate” from KGBV – Type III hostel concerned.
 - On fulfillment of conditions of the agreement.
 - Four self-inking carbon copies of the GSTIN invoice as well as bank details for payment purpose.
 - Receipt & outcome of Post Delivery Inspection (PDI) Report.
 - On fulfillment of conditions of the agreement
 - Four self-inking carbon copies of the GSTIN invoice as well as bank details for payment purpose.
- (ii) No advance payment shall be made, or no payment shall be entertained on negotiation through Bank.
- (iii) Deduction of tax at source shall be made at the appropriate rate as per prevailing law.

14. Penalty:

- (a) If the work is delayed for any reason for which the TIA is not responsible, penalty @ 0.5 % per week or part thereof on the total cost maximum up to 10% of the contract value will be imposed on the firm under orders of appropriate Authority. The TIA reserves the right to forfeit the Performance Security & debar the bidder from participating in any other bid of his/her office. In such cases the TIA may write Govt. for blacklisting the firm.
- (b) If the Post Delivery Inspection of the quality of items shows negative results, then penalty will be imposed proportionately on the total cost after deduction of tolerance limit prescribed by Govt., if any.
- (c) If the quality of items is found to be dissatisfactory, penalty as suggested by the purchase committee will be imposed.

15. Only one tender should be submitted by one party. Submission of more than one tender will lead to rejection of all proposal of the bidder.

16. The bidder/s may use separate piece of paper, where the space provided in the formats in this tender document for submission of information, is not sufficient. The information in the separate sheet of paper shall be in prescribed format and its page should be serially numbered and duly authenticated.
17. All the information submitted or supplied in the formats of this tender document shall be presumed to be true to the best of the knowledge of the bidder/s.
18. No document as required and mentioned in the Bid shall be submitted in the Technical bid / Financial bid documents unless otherwise specifically mentioned therein. All required documents shall be uploaded with serial number and page mark.
19. The TIA reserves the right to modify any term in the bid document at the time of execution of contract, if felt necessary.
20. The bid validity period is 90 days from the date of opening of the Financial Bid. Accordingly, the bidder shall submit the Bid.
21. The TIA reserves the right to reject any or all the bids without assigning any reason thereof. The TIA also reserves the right to modify any term in the bid document at the time of execution of contract, if felt necessary.
22. **Resolution of Disputes:**
 - (a) Any dispute between the Tender Inviting Authority and the successful bidder/s should be addressed to the other party only in writing in their respective letter heads signed only by the designated signatories as in contract agreement. Both the parties shall make every effort to resolve the same amicably by mutual consultations.
 - (b) If both the parties fail to resolve their dispute or difference by such mutual consultation within twenty-one days of its occurrence, the same will be referred to by either party for conciliation to the conciliation panel. For that purpose, both the parties, shall nominate each one member, and both the nominated members shall form the Conciliation panel. In case the panel members report failure of conciliation, the matter shall be referred to arbitration, by the Arbitrator, to be nominated by the Collector Nabarangpur. The Collector Nabarangpur shall nominate an Arbitrator, whenever required or when a request is made by the successful bidder/s, after the failure of conciliation, to nominate an Arbitrator. The arbitration proceeding shall be as per the provisions of the Arbitration and Conciliation Act 1996 of India.
23. **Applicable Law and Jurisdiction of Courts:**
 - (a) The Contract shall be governed by and interpreted in accordance with the existing law of India in force.
 - (b) All disputes relating to the contract is subject to the pecuniary jurisdiction of the Court at Nabarangpur.
