The District Project Coordinator, Samagra Shiksha, Nabarangpur invites bids from the reputed & credible firms / agencies for "for Supply of Pipe Band & Brass Band to PM SHRI Schools under Nabarangpur District. The detailed terms & conditions of the above bid are as under;

**SCOPE OF WORK AND GENERAL INSTRUCTIONS FOR BIDDERS**

**1. Eligibility Criteria :**

The firms /agencies must have:

- (a) Valid Aadhar Udyam Registration Certificate.
- (b) Office setup in the state of Odisha
- (c) Valid PAN
- (d) Valid GST Registration Certificate.

**2. Application Procedure:**

- (a) The Bid has been invited under two bid system i.e. **Technical Bid and Financial Bid**. The interested bidders are advised to submit two separate sealed envelopes super scribed "Technical Bid for Supply of Pipe Band & Brass Band to PM SHRI Schools" & "Financial Bid for Supply of Pipe Band & Brass Band to PM SHRI Schools". Both sealed envelopes should be kept in another sealed envelope super scribed "Tender for supply of Pipe Band & Brass Band to PM SHRI Schools of Nabarangpur District".
- (b) **Technical Bid & Financial Bid.**  
The Bidder has to fill up the Technical bid Form (Tech-1, Tech-2, Tech-3, Tech-04) & submit it with a separate envelope with all self-attested documents / papers as mentioned in para-2 (f). Similarly, the Financial Bid form has to be filled up as per prescribed form (Fin-1 & Fin-2) and to be submitted in separate sealed envelope. The bidder is to quote per item in the prescribed format (FIN-2). The per item rate shall include G.S.T and all other charges/levies/duties, transportation cost & delivery of the complete materials to School Point.
- (c) The tender should be addressed to O/o the District Project Coordinator, Samagra Shiksha, Nabarangpur, Pin-764059".
- (d) The Bid document shall be available in website [www.osepa.odisha.gov.in](http://www.osepa.odisha.gov.in) & [www.nabarangpur.odisha.gov.in](http://www.nabarangpur.odisha.gov.in) and the cost of the tender paper is to be enclosed in shape of crossed Demand Draft / banker's Cheque in favour of "District Project Co-ordinator, Samagra Shiksha, Nabarangpur" payable at Nabarangpur along with the **Technical BID**.
- (e) **Earnest Money Deposit (EMD):** The bidder is to submit EMD amounting to **Rs.80000/- Rupees (Eighty Thousand) Only**. The EMD (refundable - without interest), may be submitted in shape of Demand Draft / Banker's cheque/ Bank

Guarantee (**Format A**) from any Nationalized or scheduled bank drawn in favour of "District Project Co-ordinator, Samagra Shiksha, Nabarangpur" Payable at Nabarangpur, failing which the tender shall be rejected summarily. In case of bank guarantee, it should be valid up to at least 90 days beyond the date of opening of Financial bid. The instrument in original should be necessarily accompanied with the Technical Bid. The EMD of the un-successful bidders shall be refunded within 30 days after award of contract. The EMD shall be forfeited in the event of withdrawal of the tender once submitted OR in case of a successful bidder who (i) fails to execute the agreement within specified period & (ii) not submitted performance security and/or express its inability to supply the finished material within the stipulated period. The EMD of successful bidder shall be refunded after receipt of Performance security.

- (f) The interested Bidders are to enclose self-attested photocopies of the following valid documents /papers in the **Technical Bid envelope**. The proposal submitted without the following documents / papers shall not be considered.
- (a) Valid Udyam Registration or Regn. Certificate under Partnership Act or Companies Act.
  - (b) Valid PAN along with Income Tax filing as per Sl. No. 05 of Tech 3
  - (c) Valid GST Registration Certificate along with GST returns as per Sl. No. 06 of Tech 3.
  - (d) DD/Bankers Cheque amounting to Rs.2500/- (Rupees Two Thousand Five Hundred) only as bid processing fee
  - (e) EMD amounting to 80,000/- (Rupees Eighty Thousand) only in shape of Demand Draft / Bankers Cheque / Bank Guarantee
  - (f) The Bidder should have Average Annual Turnover of INR 100.00 Lakh (Rupees One Crore only) in last three financial years. Proof to be submitted by the bidder from a Chartered Accountant. Valid Turnover Certificate of bidder for the FY 2021-22, 2022-23 & 2023-24 with UDIN.
  - (g) Applicant should not be blacklisted by any Govt. entity or by any other organization, not have any legal proceedings within a period of three years preceding the procurement process or not have been otherwise disqualification pursuant to debarment proceedings.\* The bidder should furnish an undertaking to this effect through an affidavit in non judicial stamp paper and duly notarized.
  - (h) Duly filled in, signed & sealed Tech-1, Tech-2, Tech-3 & Tech-4 formats.
  - (i) Bidder must submit ISO-9001:2015, ISO-14001:2015 and ISO-45001:2018 of the respective OEMs & Brand Registration Certificate of same category product.
  - (j) Manufacturers Authorization letter in favor of bidder/tenderer from the manufacturers of the items. BID specific authorization contact details of OEM mentioned in Authorization certificate, it will be cross check by its OEM. The manufacturer should be an ISO certified company.
  - (k) Sample of the Pipe Band & Brass Band must be submitted while opening of technical bid.
  - (g) **The interested Bidders are to enclose duly filled in, signed & sealed FIN-1, FIN-2 formats in the Financial Bid envelope.**
  - (h) **All materials must be of a reputed brand.** Only single price should be quoted for each item and if multiple price is quoted under different options, the

rate quoted by the firm in the 1<sup>st</sup> options only will be valid and consider for evaluation.

3. The Bidder who meets the requirements specified in the Technical Bid will only be considered for participating in the Financial Bid. Financial Bid of the technically disqualified bidders will not be considered & opened.
4. The quoted price in the financial bid should not be exceeding the price in the open market.

5. **Submission & opening of Tender:**

- (a) The interested Bidders may submit the tender document complete in all respects along with EMD, bid processing fee and other requisite documents on or before 24/11/2025 (in all working days) addressed to "District Project Co-ordinator, Samagra Shiksha, Nabarangpur" only by **Registered Post / Speed Post / Courier**. The Authority is not responsible for any postal delay. No other mode of submission of bid shall be entertained.
- (b) **Late Bidders:** Any bid received by the authority after the prescribed time and dateline for submission of bids will not be considered and opened. Thus the same is deemed to be rejected.
- (c) The Technical bids shall be opened on the scheduled date and time at **District Project Co-ordinator, SamagraShiksha, Nabarangpur or at Conference Hall, Collectorate, Nabarangpur** in the presence of the bidders or representatives of the bidders, if any, who wish to be present on the spot at that time.
- (d) The Financial Bid of only those bidders will be opened whose Technical bids are found in order. The date, time & place of opening of Financial BID will be communicated after evaluation of Technical BID.

**7. Evaluation of BID:**

- (a) The Purchase Committee of the District Project Office will evaluate the Technical & Financial BID. The Bidder who meets the requirements specified in the Technical Bid will only be considered for participating in the Financial Bid. Financial Bid of the technically disqualified bidders will not be opened.

- (b) The technically qualified bidder quoting lowest price in the Financial bid shall be considered for award of contract.

**8. Acceptance or Rejection of the Bids:**

- (a) The TIA reserves the right to accept / reject any / all bids / cancel the entire selection process at any stage without assigning any reason thereof. No claim, whatsoever, shall be admissible for the alleged loss/damage suffered by the bidder/s on account of such rejections.
- (b) Any bid with incomplete information is liable for rejection.

**9. Award of Contract:**

The contract will be awarded to the Bidder/s substantially responsive to the Bid document & offered lowest evaluated cost.

**10. Signing of Contract:**

- (a) The successful bidder/s whose bid has been accepted will sign an agreement with the TIA within 03 days of issue of the work order.
- (b) Failure by the tenderer to comply with the requirement of above mentioned clause, the offer shall be rejected and the tenderer shall have no claim further.

**11. Performance Security Deposit:**

The selected bidder shall have to submit Performance Security Deposit of 05% of contract value in shape of bank draft / Bank Guarantee (BG) drawn on any Nationalized / Scheduled Bank in favour of the "District Project Co-ordinator, Samagra Shiksha, Nabarangpur" payable at Nabarangpur only within 03 days from issue of the work order. In case of BG, the same shall be as per the **FORMAT-B** & its validity will be at least 15 days from the date of expiry of defect liability period.

12. Post Delivery Inspection (PDI): The TIA shall do the PDI of the quality of the material either through technical committee / appropriate authority.

**13. Requirement & Delivery Schedule:**

The selected firm shall Supply of Pipe Band & Brass Band to PM SHRI Schools within 30 days from the date of issue of the work order. The requirement of Pipe Band & Brass Band may increase or decrease as per need. The total cost will be decided on the basis of actual requirement supplied.

**14. Payment terms:**

- (i) **On completion of delivery at Resource Centre point:** Payment shall be made within 30 days after receipt of the required reports / Papers/ documents as under:
- Challans towards satisfactory completion of supply of items to concerned Resource Centre point as per supply order.
  - Receipt of "receive & stock entry certificate" from concerned schools.
  - On fulfillment of conditions of the agreement.

- d. Four self-inking carbon copies of the GSTIN invoice as well as bank details for payment purpose.
- e. On receipt and outcome of Post Delivery Inspection (PDI) Report.
- (ii) No advance payment shall be made, or no payment shall be entertained on negotiation through Bank.
- (iii) Deduction of tax at source shall be made at the appropriate rate as per prevailing law.
- 15. Penalty:**
- (a) If the work is delayed for any reason for which the TIA is not responsible, penalty @ 0.5 % per week or part thereof on the total cost maximum up to 10% of the contract value will be imposed on the firm under orders of appropriate Authority. The TIA reserves the right to forfeit the Performance Security & debar the bidder from participating in any other bid of his/her office. In such cases the TIA may write Govt. for blacklisting the firm.
- (b) If the Post Delivery Inspection of the quality of material shows negative results, then penalty will be imposed proportionately as maximum up to @ 20% part thereof on the total cost as decided by the TIA.
- 16. Amendments to BID terms, conditions and issue of Corrigendum/addendum:**
- (a) Seven (07) days before the last date of submission of Bids, the TIA may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder/s, modify the Bidding Documents by amendment /corrigendum.
- (b) The amendment in shape of corrigendum/addendum will be notified on the websites [www.osepa.odisha.gov.in](http://www.osepa.odisha.gov.in) & [www.nabarangpur.odisha.gov.in](http://www.nabarangpur.odisha.gov.in) and the prospective bidder/s are requested to take cognizance of such notification/s while submitting their tender proposal.
- (c) In order to allow prospective Bidder/s reasonable time in which to take the amendment into account in preparing their bid, the TIA may, at its discretion, extend the deadline for the submission of bids.
17. Only one tender should be submitted by one party. Submission of more than one tender will lead to rejection of all proposal of the bidder.
18. The bidder/s may use separate piece of paper, where the space provided in the formats in this tender document for submission of information, is not sufficient. The information in the separate sheet of paper shall be in prescribed format and its page should be serially numbered and duly authenticated.
19. All the information uploaded & submitted or supplied in the formats of this tender document shall be presumed to be true to the best of the knowledge of the bidder/s.
20. No document as required and mentioned in the Bid shall be submitted in the Technical bid / Financial bid documents unless otherwise specifically mentioned therein. All required documents shall be uploaded with serial number and page mark.
21. The TIA reserves the right to modify any term in the bid document at the time of execution of contract, if felt necessary.
22. The bid validity period is 90 days from the date of opening of the Financial bid. Accordingly, the bidder shall submit the Bid.

23. The TIA reserves the right to reject any or all the bids without assigning any reason thereof. The TIA also reserves the right to modify any term in the bid document at the time of execution of contract, if felt necessary.

**24. Resolution of Disputes:**

- (a) Any dispute between the Tender Inviting Authority and the successful bidder/s should be addressed to the other party only in writing in their respective letter heads signed only by the designated signatories as in contract agreement. Both the parties shall make every effort to resolve the same amicably by mutual consultations.
- (b) If both the parties fail to resolve their dispute or difference by such mutual consultation within twenty-one days of its occurrence, the same will be referred to by either party for conciliation to the conciliation panel. For that purpose, both the parties, shall nominate each one member, and both the nominated members shall form the Conciliation panel. In case the panel members report failure of conciliation, the matter shall be referred to arbitration, by the Arbitrator, to be nominated by the Collector cum Chairman SS, Nabarangpur. The Collector cum Chairman SS shall nominate an Arbitrator, whenever required or when a request is made by the successful bidder/s, after the failure of conciliation, to nominate an Arbitrator. The arbitration proceeding shall be as per the provisions of the Arbitration and Conciliation Act 1996 of India.

**25. Applicable Law and Jurisdiction of Courts:**

- (a) The Contract shall be governed by and interpreted in accordance with the existing law of India in force.
- (b) All disputes relating to the contract is subject to the pecuniary jurisdiction of the Court at Nabarangpur.
