Applications with bio data of retired Government employees worked under Revenue Administration/Experienced worker and eligible candidates are invited for engagement to work under Tahasildar-cum-Special Land Acquisition Officer for smooth function of LA Collector under Sec 3(g) of RFCTLA R&R Act 2013 read with Rule 2(f) of the Odisha RFCTLA R&R Act 2016 in respect of the Project "Jeypore-Nabarangpur New BG Rail Link Project". **ELIGIBILITY OF THE CANDIDATE:**

**1. For the post of Revenue Supervisor/ Revenue Inspector:**

Retired from the post of Revenue Supervisor/ Revenue Inspector (Age Below 65 Years).

**2. For the post of Senior Assistant:**

Retired from the post of Section Officer/ Senior Assistant (Age Below 65 Years).

**3. For the post of Computer Operator:**

(a) He/she shall have passed at least +2 examination or such other qualification equivalent to +2 examination from a recognized University.

(b) He/sheshall have at least passed Diploma in Computer Application from a recognized Institute,

(c) He/she shall be over 18 years of age & below 45 years of age.

(d) He/she shall be able to speak, read and write Odia and must have passed at least a test in Odia equivalent to the M.E. standard.

- (e) He/she shall be of good character.
- (f) He/she shall be sound health, good physique and free from any organic or bodily infirmity.
- (g) He/she should not have more than one spouse living, if married.

**4. For the post of Amin –cum-Tracer:**

- (a) Retired from the post of Amin/ Assistant Revenue Inspector (Age Below 65 Years).

**5. For the post of Chain man:**

- (a) Retired from the post of Process Server/ Peon (Age Below 65 Years).

**OR**

- (a) He/she shall be over 18 years of age & below 65 years of age.
- (b) He/she shall be able to speak, read and write Odia and must have passed at least a test in Odia equivalent to the M.E. standard.
- (c) He/she shall be of good character.
- (d) He/she shall be sound health, good physique and free from any organic or bodily infirmity.
- (e) He/she should not have more than one spouse living, if married.

**6. For the post of Process Server:**

- (a) Retired from the post of Process Server/ Peon (Age Below 65 Years).

**OR**

- (f) He/she shall be over 18 years of age & below 65 years of age.
- (g) He/she shall be able to speak, read and write Odia and must have passed at least a test in Odia equivalent to the M.E. standard.
- (h) He/ She shall be of good character.
- (i) He/she shall be sound health, good physique and free from any organic or bodily infirmity.
- (j) He/she should not have more than one spouse living, if married.

**SELECTION PROCEDURE:**

1. For the post of RI/RS, SO, Amin, Chain Man and Process Server: if more than one application received for the above post most experience among them will be selected.
2. For the post of DEO: if more than one application received for the of DEO, then written test and practical test will be conducted.

**N.B: Retired employees having expertise will be given preference in all category.**

**N.B: There shall be no reservation for the above post.**

**TERMS AND CONDITIONS:**

1. The contractual engagement shall be made initially for a period of 6 months or till completion of the project, whichever is earlier.
2. The appointee has to discharge such duties and in such a manner, as may be prescribed by the Tahasildar-cum-CALA, Nandahandi.
3. The retired Govt. employees against whom a vigilance case or departmental proceeding or criminal prosecution is contemplated or pending or who has been penalized for misconduct during the period of preceding five years of his/her

retirement, or is a member of a political party will not be considered for re-engagement.

4. The period of contractual engagement shall not be counted as Government service for the purpose of pension and any other retirement benefit.
5. The engaged retired employees/ fresh candidates will be subject to and will abide by the conduct rules applicable to the Government Servants.
6. The contractual engagement may be terminated at any time by the Tahasildar-cum-CALA, Nandahandi for unsatisfactory performance, misappropriation, negligence or causing loss to Government, without any prior notice.
7. In case the engaged employees to resign from the engagement, he/she must have to give one-month advance notice in writing to the Tahasildar-cum-CALA, Nandahandi. After expiry of the notice period, he/she may be relieved after handling over full charges of records to the relieving officer as decided by the Tahasildar-cum-CALA, Nandahandi.
8. The Tahasildar-cum-CALA, Nandahandi reserves the right to reject any/ all applications without assigning any reason thereof.
9. The interested eligible candidates shall apply to the office of the Tahasildar-cum-CALA, Nandahandi in the prescribed format by Regd. Post/ Speed Post/ Personal delivery only which should reach on or before. 15.12.2025. Applications received in the office after the last date shall be summarily rejected.
