NOTICE

Sub: Invitation of proposals from PRI Members, Elected Representatives and Civil Society Members under BGBO Comprehensive Guidelines.

In pursuance of the BGBO Comprehensive Guidelines issued by the Government of Odisha in Panchayati Raj & Drinking Water Department, communicated vide Letter No. 1155, dated 09.01.2026, notice is hereby issued inviting proposals / suggestions / recommendations from PRI Members, Elected Representatives and Civil Society Members of the district for consideration under the said guidelines.

(1) Eligible Stakeholders:

Proposals may be submitted by the following stakeholders as envisaged under the BGBO Comprehensive Guidelines:

- (i) Members of Panchayati Raj Institutions (PRIs) at all tiers,
- (ii) Elected Representatives, including Hon'ble Members of Parliament and Members of Legislative Assembly,
- (iii) Civil Society Members / Organizations having experience in community development, social mobilization and public welfare activities within the district.

(2) Guiding Principles:

- (i) The proposals shall be need-based, community-oriented and in conformity with the objectives, norms, and provisions of the BGBO Comprehensive Guidelines.
- (ii) Proposals not adhering to the provisions of the said guidelines shall not be considered.

(3) Mode of Submission:

- (i) Proposals shall be submitted in writing, duly signed, along with supporting documents, if any.
- (ii) The project proposal proposed at Gram Sabha should be routed through the Block Nodal Officers.
- (iii) All proposals shall be addressed to the Collector, Nabarangpur within the stipulated time.


All concerned should ensure that all proposals must reach the undersigned on or before 28.01.2026 (date). Proposals received beyond the stipulated date shall not be considered.

(4) Miscellaneous:

- (i) Submission of a proposal does not automatically confer any right for approval or implementation.
- (ii) The proposals shall be examined by the District Level Committee and shortlisted strictly as per the BGBO Comprehensive Guidelines.
- (iii) The decision of the District Level Authority / District Administration shall be final and binding.
- (iv) The undersigned reserves the right to accept or reject any or all proposals without assigning any reason thereof.

This notice is issued for wide circulation among all concerned for information and necessary action.






