


1. Self certificate that the Agency has not been blacklisted in the past.

3. Size of display board will be of 4 ft X 4 ft.
4. The display board must be made from Iron Frame with Flex Banner.
5. Previous experience of supply of display boards of any Govt agencies must given (Order copy must be enclosed).
6. The lowest quoted price firm/ firms will be ordered for supply of display boards.
7. The payment will be made after supply of the display board and receipt of fund for the above purpose at this end.
8. The authority reserves the right to accept or reject any or all quotations without assigning any reasons thereof. Besides, the applications received in incomplete forms after due date will also be rejected.
