
**CONTRACTUAL APPOINTMENT**

Separate application has to be submitted for each post. Any application received after this time & date shall be rejected. ## **TERMS & CONDITIONS:**

- A. The above posts will be filled up on contractual basis for a term of 11 months with monthly remuneration as noted against each and subject to renewal as per the Society norms basing on the performance and subject to continuance of the programme. The selection will be made on merit basis. The selected candidates shall prepare him/her to stay in the Ashram for 24 hours in a day for caring of orphan/abandoned/surrendered/rescued children. Their usual Official Holidays and Casual leave /Medical leave/Maternity leave may be provided as per the norms. They will perform their duties as assigned them by the higher officials from time to time.
- B. The shortlisted candidates will be invited for interview-cum-verification of certificates/written or Computer test & personal Interview. The candidates should submit the following documents have to be attached with the application forms:
1. Self – Attested Photocopy of Secondary, HSC, Graduation, Post-Graduation, Computer Course or any other professional qualification certificate and Mark sheets.
  2. One recent self-attested Colour Photograph (3.5 x 4.5 Size) should be affixed to the application form.
  3. Self Attested Certificate of experience issued from previous employer if any.
  4. Self attested Police verification certificate. *(If any)*
  5. One Self attested recent Character Certificate from a gazetted Officer.
  6. Self Declaration regarding non-involvement in any criminal activities especially child related offence.
  7. For the post of House Mother and Helper-cum-Watchman, the candidates should submit an undertaking that she/he is willing to stay in Ashram with children for all the time during her/his job tenure except emergency leaves. There is less scope to go home.

- C. The Merit list shall be drawn up on the basis of weighted percentage of marks obtained in all categories mentioned in the table above. In case more than one candidate has equal weightage of marks, the candidate with past experience of working with children will be given preference. The decision of the selection Committee in this regard shall be final.



- D. The above positions are purely temporary and also co-terminus at any time with the sanction of funds. Canvassing in any form will render the candidate disqualified for the position. Candidates who are already working in Child Welfare/Child Development/CCI/ Civil Society or Govt. Sector either on regular or on contractual basis have to submit **No Objection Certificate** from concerned employer during their joining.
- E. If any candidate is found to have suppressed any material information or furnished false information/ documents, his/her case shall not be considered for the post applied for and in case already engaged on the basis of the said information/ documents, he/her service shall be terminated from the Job at any time forthwith.
