

PROCEEDINGS OF TENDER COMMITTEE MEETING HELD ON 03.02.2026 AT 3.00 PM FOR ENGAGEMENT OF A HIRED VEHICLE TO BE USED BY THE PROGRAMME OFFICER, DIST. CELL IN DISTRICT SOCIAL WELFARE SECTION, COLLECTORATE, NABARANGPUR.

Tender Call Notice No. 215/2026-MV dated 27.01.2026 for hiring of a private vehicle for official use by the Programme Officer, Dist. Cell, O/o the District Social Welfare Officer, Collectorate, Nabarangpur, was published and also hosted on the District NIC website.

As per the scheduled programme, the Tender Committee meeting was held on 03.02.2026 at 3.00 PM in the chamber of the District Social Welfare Officer, Nabarangpur, for finalization of Travel Agencies/Tour Operators/Individuals for hiring of a private vehicle.

The meeting was held under the Chairmanship of the District Social Welfare Officer, Nabarangpur. The following members were present.

It is observed that only 05 sealed tender covers were received within the prescribed time period. 03 nos. of bidders/their authorized agents/ representatives were present during the opening of the Tender Box.

The Jr. MVI, RTO Office, Nabarangpur (as member) has checked the entire vehicles quoted in the tender process through the Vehicle Information Detection System (VIDS) to verify the correct information of the vehicles. The Tender Committee has gone through the documents submitted by the bidders. The details are as below:
