However, The firm has been blacklisted for last year by the Office of the CDM & PHO, Nabarangpur vide Letter No. 4107 dated 25.04.2025 due to non supply of a Particular Item. As the blacklisting period ends on 24.04.2026, the Committee decided to allow the firm to participate in the present tender process.
